Michael Wilkinson (Trinity Western University) presents "*Lonnie Frisbee: The Life and Death of a Hippie Preacher*", a documentary about a hippie who has a vision of Jesus while taking drugs, and then preaches to many hippies, leading them to Christianity during the Jesus People movement in the 1970s. Two prominent evangelical denominations experience growth in California at this time because of his work. However, Lonnie Frisbee, the Hippie Preacher, is also a homosexual and eventually dies of AIDS. The church, after learning so, writes him out of their history. The film is produced and written by David Di Sabatino, and asks some hard questions about why the church acted as it did, and also raises some interesting questions about Charismatic movements and those who lead them.
